Project description	<p>The Caribbean Region climate change mitigation project is an initiative of Forestal Monterrey Colombia S.A.S (FMC), which, with the support of Greenwood Resources, leads the development of commercial forest plantations and protects areas of tropical dry forest (bs-T) in the departments of Bolivar and Magdalena in Colombia. The FMC company implements greenhouse gas (GHG) mitigation actions, developing reforestation and forest conservation activities to avoid deforestation and degradation of the natural forest on its land through the mechanism for reducing emissions from deforestation and degradation (REDD)+. FMC seeks to reduce GHG emissions in approximately 5,864 hectares of tropical dry forest in the Colombian Caribbean region. Likewise, FMC has Melina (Gmelina Arborea) and Ceiba tolúa (Pachira quinata) plantations with which it seeks to remove more than 80,000 tCO₂e in an area of 2,416.8 ha.</p>
Location	<p>The project area is located in the Continental Caribbean of Colombia, and has direct influence in the municipalities of Córdoba Tetón, El Carmen de Bolívar and Zambrano in the department of Bolívar, belonging to the sub-region of Los Montes de María and bordering the lowland dynamics of the Magdalena River, other tributaries and the Momposina Depression. It also includes another area located in the municipality of Ariguaní, department of Magdalena, specifically in the township of El Carmen de Ariguaní, whose socioeconomic environment is adjusted to a more rugged and mountainous terrain in the transition zone between the Momposina Depression and the Sierra Nevada de Santa Marta. The two project areas are known as Monterrey in the department of Bolivar and Punto Nuevo in Magdalena.</p>
